#### Metrics - Handouts

- Clinical Portal utilization represents the usage of the system. Large changes recently have been driven by LME/MCOs (Tailored Plans).
- Data Connections by Month: Note pent-up demand as a result of HealthShare upgrade that was relieved after the upgrade completed in Sep 2024.
- Research post Helene medical encounters (findings as of Nov 8, 2024)
- Testimonials reflect usage of HIE and impact on their business.

## **Budget and Contracts**

- General fund appropriation = \$19.4 M
- Two APD documents approved by CMS: IAPD-U \$19 M (with federal match) and OAPD \$5.4 M (based on proportion of state population served by Medicaid 30%).
- Annual SAS amendment executed in December: \$16 M calendar year.
  - NC\*Notify changes for CY 2026 Moving to a new approach starting in 2026, with development in 2025.

## Staffing

Seven staff have started at HIEA since the beginning of December with heavy investment in project management, Medicaid administration, and quality improvement:

Vacant positions with candidates identified for four positions. Many of the positions fall under operations and data quality and provider outreach.

- Business Development/Outreach Specialist (Permanent)
- Provider Relations Specialist (Contractor: APD -Funded)
- Analytics and External Services are fully staffed

#### **HIEA Priorities**

- Manatt Health partnership is focused on identifying and executing strategies based on ability to perform scans across the landscape and policy analysis.
- Currently engaged in a two-step process for roadmap development: Strategic Priority Setting and Implement Plan Development. This will be followed by implementation plan development.

- The HIEA has identified multiple key stakeholders across government (DHHS, DAC, DPI, GA) and non-government entities (providers, payers, patients, CBO/HSOs, SAS, EHR vendors).
- Stakeholder-supplied use cases include food scarcity and SNAP enrollment, pediatric autism service utilization from clinical and non-clinical sources.

- General Assembly begins Jan 29, 2025
- Waiting on bill filing deadlines (General Assembly is working on simplifications)
- The crossover deadline is May 8, 2025
- Revenue estimates: Mid-April Early May
- Expecting good revenue report, combine with Treasurer and SHP, and Hurricane Relief
- Hurricane Helene relief bill expected in February
- House committees' reformation in progress
- Senate committees will remain the same

# **Legislative Priorities for Long Session**

- Revised Compliance Framework for HIE Act
- Why PA's Decreased from 2023 to 2024, which is also reflected in the volume of data received, but clinical portal utilization has increased.
- Perception of a relaxed or delayed deadline led to a loss of urgency to connect with certain providers. This requires that we put a compliance framework back in place to annually exempt smaller state-funded providers based on claims volume and revenue but requires larger provider to participate in through financial penalties separate from claims.

- NCLDS is not a data warehouse. Users of data warehouses are often concerned with where their data is going. NC LDS just provides a service, not an attempt to populate our warehouse.
- NCLDS is a process for retrieving, linking, deidentifying, packaging, securely delivering data in a common space. Most states do not have this approach. Security, privacy, and data quality are critical aspects of the framework.
