### I. Introduction & Version History

This user guide was developed jointly by the North Carolina Health Information Exchange Authority (NC HIEA) and SAS Institute to assist organizations planning to send Health-Related Social Needs (HRSN) data – aka Social Determinants of Health (SDOH) or Health-Related Resource Needs (HRRN) – to NC HealthConnex as part of the partnership between the NC HIEA and North Carolina Department of Health and Human Services (NCDHHS), Division of Health Benefits (DHB) to improve the collection and exchange of HRSN screening data.

The program's goals are for all participating organizations to map their HRSN screening questions to the same standard questions as defined by Logical Observation Identifiers Names and Codes (LOINC) and provide the same standard answers (as defined by LOINC) for consistency in continuity of care and population health. Participants have the flexibility to use the HRSN screening instruments and questions/answers of their choosing, mapping those values to the standard LOINC codes in the assignment table in Section III.

### ZPV Segment Table - Keys

The following table defines the various column details in the ZPV message segment tables.

Sequence/Use ***	'***' = If the Answer Timestamp (3.7) is not populated in encounter-based ADT, then NC HealthConnex will use the encounter start date/time.  '***' = The Answer Timestamp (3.7) is required in non-encounter-based ADT messages.			

### Identifying Screening Tools

Within the ZPV segment, each HRSN screening question and answer should indicate the screening tool from which the question/answer pair originates. The tool may be a standardized screening instrument or an internally developed (homegrown) tool. Many standardized tools – including their names and associated codes – are published by the Gravity Project. For more details, see here: Social Risk Terminology Value Sets - Gravity Project - Confluence.



### III. Questions and Answers

Transmission of HRSN screening questions and answers to NC HealthConnex should only include the six questions and answers below.

Participants can choose to send either the LOINC Question Code/Text and corresponding Answer Code/Text or the Alt LOINC Question Code/Text and corresponding Answer Code/Text.

### IV. Implementation Steps

### Option 1 (Preferred)

- 1. Establish or confirm test connection between NC HealthConnex and the participant's system.
- 2. NC HealthConnex will require a sample set of test messages to analyze and ensure the messages meet the data target requirements.
- 3. If any data elements are missing or are not being sent in the correct format in the test messages, the NC HealthConnex technical team will work with the participant and/or their vendor on options to adjust the messages being sent. Several rounds of analysis may be required depending on the number of changes required.
- 4. Once validation of test messages is complete, NC HealthConnex will request that the participant send a larger volume of production-level messages to our test environment to perform analysis on those messages.
- 5. If any data elements are missing or are not being sent in the correct format in the production messages, the NC HealthConnex technical team will work with the participant and/or their vendor on options to adjust the messages being sent. Several rounds of analysis may be required depending on the number of changes required.
- 6. Once validation of production messages is completed and approved, the NC HealthConnex team will work with the participant and/or their vendor to schedule a date for go-live in production.
